**NFARMC RESOLUTION No. 01

**RESOLUTION ENDORSING TO THE SECRETARY OF AGRICULTURE
REPRESENTATIVES OF THE MUNICIPAL FISHERFOLK SECTOR AND COMMERCIAL
FISHING SECTOR FROM THE NFARMC TO BE APPOINTED AS MEMBERS OF THE
ADJUDICATION COMMITTEE**

WHEREAS, the National Fisheries and Aquatic Resources Management Council (NFARMC) is a multi-sectoral body composed of representatives from all major stakeholders in Philippine fisheries and serves as an advisory and recommendatory body to the Department of Agriculture (DA);

WHEREAS, Section 130 of Republic Act No. 8550, as amended by Republic Act No. 10654, (the "Amended Fisheries Code") states that the Department shall organize and designate the composition of the Adjudication Committee, which shall be composed of the bureau director as chairperson and four (4) other members to be designated by the Secretary;

WHEREAS, Rule 130.1 of the Implementing Rules and Regulations of the Amended Fisheries Code provides for the composition of the Adjudication Committee which includes a representative of the municipal fisherfolk sector and a representative of the commercial fishing sector, both from the NFARMC;

WHEREAS, during the First Quarter Meeting of the NFARMC held via zoom teleconferencing on 10 January 2022, the Council selected Mr. Alexander M. Agra as representative of the municipal fisherfolk sector and Mr. Peter Paul D. Santos as representative of the commercial fishing sector, to be endorsed to the Secretary of Agriculture for appointment as members of the Adjudication Committee;

WHEREAS, Mr. Alexander M. Agra and Mr. Peter Paul D. Santos signified their acceptance thereof;

NOW, THEREFORE, BE IT RESOLVED, that after selection and acceptance thereof, the NFARMC hereby endorse to the Secretary of Agriculture **Mr. Alexander M. Agra** as representative of the municipal fisherfolk sector and **Mr. Peter Paul D. Santos** as representative of the commercial fishing sector, to be appointed as members of the Adjudication Committee;

RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the Secretary of the Department of Agriculture, the Bureau of Fisheries and Aquatic Resources and the Adjudication Committee Secretariat;


