**RESOLUTION ENDORSING TO THE PHILIPPINE COMMITTEE AGAINST ILLEGAL, UNREPORTED, AND UNREGULATED FISHING THE PRIVATE SECTOR MEMBERS FROM THE NATIONAL FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCIL**

**WHEREAS,** the National Fisheries and Aquatic Resources Management Council (NFARMC) is a multi-sectoral body composed of representatives from all major stakeholders in Philippine fisheries and serves as an advisory and recommendatory body to the Department of Agriculture (DA);

**WHEREAS,** Sec. 2 of Executive Order No. 154, series of 2013, provides for the Establishment of the Philippine Committee against Illegal, Unreported, and Unregulated Fishing and its membership;

**WHEREAS,** under the last paragraph of Section 2 of Executive Order No. 154, series of 2013, it is provided that the private sector members of the Committee shall be as follows: one (1) fisherfolk representative of the National Anti-Poverty Commission (NAPC), and two (2) municipal and two (2) commercial fishers from the National Fisheries and Aquatic Resources Management Council;

**WHEREAS,** during the Second Quarter Meeting of the NFARMC held at the MICROTEL by Wyndham, UP - Ayala Land, Technohub, Commonwealth Ave., Diliman, Quezon City on 29 April 2022, the Council selected the following members to be the representatives of the NFARMC in the Philippine Committee against Illegal, Unreported, and Unregulated Fishing:
